Reminder:

To qualify for this category, the subscriber must:

- Be a King County resident.
- Pay a NON-REFUNDABLE fee of \$20.00 (for library subscribers) or \$30.00 (for non-subscribers.) This entitles the person named to subscription privileges for the period beginning on June 1st and ending on May 31st the following year. The Legal Eagle subscriber account allows the person named to check out DVDs from the Library's DVD collection. It does not allow the borrower to check out any other Library materials. These privileges are non-transferrable.
- A maximum limit of 3 DVDs may be checked out at any given time on a Legal Eagle subscriber account. If the 3 DVD limit is reached, some DVDs must be returned before more DVDs can be checked out.
- Subscribers are required to pay all fines and charges incurred through the use of this account.

Legal Eagle Subscriber Rules

The Law Library maintains an annual subscription plan for those residents of King County who wish to borrow DVDs from the Library and who agree to the following rules and conditions.

To become a subscriber for the Legal Eagle DVD collection the subscriber must pay a fee of \$20 per year for current King County Law Library subscribers, or \$30 per year for non-subscribers.

Only the authorized subscriber may check out and use the DVDs. The subscriber must identify him/herself. The subscription account holder is responsible for all fines and charges incurred.

Loan period: Subscribers may check out a maximum of three DVDs for one week, with an option to renew for an additional week by calling the Library at 206-296-0940.

Fines and Charges: A fine of 50 cents per day shall be charged for each overdue item. The subscriber will be billed for all fines and charges as they are incurred. Subscribers who have not returned library materials that have been overdue for 30 days will incur a lost DVD fee equal to the replacement cost of the DVD. If a subscriber returns a lost DVD before payment of the replacement cost of the DVD, an overdue fee of \$15.00 per DVD will be substituted for the lost DVD fee.

Suspension and Termination: When the total amount of a subscriber's unpaid fines and charges incurred equals or exceeds \$50.00, the subscription account privileges of that subscriber will be suspended. Suspended accounts may be reinstated upon receipt of payment for all outstanding fines and charges. A subscriber who flagrantly or persistently violates the subscription rules shall have their subscriber privileges suspended or terminated by the Board of Law Library Trustees.

The subscription fee is an annual non-refundable fee. The subscription period runs from June 1st until May 31st of the following year.
